April 20<sup>th</sup>, 2021

Regular Monthly meeting of the Town of Warner was called to order by Chairman Ralph Smrecek Jr.

Supervisor present: Brian Opelt, Bruce Elmer

Others present: Carl Opelt, Paul Bugar Jr., Marlin Martin, Tony Horvat, Tim Voight, Jennifer Kujawa and Jerome Krempasky

Open Forum: Tim Voight spoke on insurance coverage. Tony Horvat spoke on the revaluation and town road bans. Marlin Martin spoke on town road bans.

Minutes of March 9<sup>th</sup> were presented. Motion Brian Opelt, seconded Bruce Elmer to approve. Motion carried.

Treasurer's report was presented. As of April 20<sup>th</sup> there was \$217,692.87 in checking account, \$1,021.06 in money market, \$61,819.38 in equipment fund, and \$72,050.56 in building fund. Motion Ralph Smrecek Jr., seconded Brian Opelt. to approve treasurer's report as presented. Motion carried.

Motion Bruce Elmer seconded Brian Opelt to pay delinquent garbage bills as presented. Motion carried.

LRIP bids were opened. Paul Bugar Trucking bid \$73,883.40 and Opelt Sand and Gravel bid \$63,544.00. Motion Ralph Smrecek, seconded Brian Opelt to award Opelt Sand & Gravel the LRIP bid. Motion carried.

Gravel bids were opened. Opelt Sand and Gravel bid \$12.48 per yard and Paul Bugar Trucking bid \$12.74. Motion Ralph Smrecek Jr., seconded by Bruce Elmer to award Opelt Sand and Gravel the gravel. Motion carried.

Motion Ralph Smrecek Jr. seconded Brian Opelt to place \$30,000 in the machinery fund. Motion carried.

Motion Ralph Smrecek Jr., seconded Bruce Elmer to grant culvert permits to Marlin Martin, Jim Kirn, and Ken Martin. Motion carried.

Tractor tires were tabled.

Motion Bruce Elmer, seconded Brian Opelt to adopt the revised recycling ordinance. Motion carried.

Road work was tabled.

Motion Ralph Smrecek Jr., seconded Bruce Elmer to lift town road bans on April 21st except on section of Century Road west of County O. Motion carried.

Discussion was held on Greenwood Fire Department wish list.
